The president called the meeting to order and declared it open for such business as may come before the board.

The board approved the minutes of the board meeting held on February 10, 2015.

Wendy Austin reported as to bookkeeping matters within the District.

Ken Byrd reported as to the status of tax collections within the District. The District is 95% collected for 2014.

Dan Wright reported as to operational matters within the District. There are 2,078 connections in the District.

John Bleyl reported as to engineering matters within the District.

The board unanimously approved a consent to encroachment for Roger and Leigh Billingsley.

The board unanimously approved a letter of credit agreement with Compass Bank.

Director McFarland discussed the planning project for the District's budget.
